Vintage Faire Mall has limited space at the mall for our performances. We enjoy providing a venue for holiday entertainment for the community outside in our Village, but must adhere to guidelines that allow us to enhance, not hinder the shopping experience.

OUTSIDE PERFORMANCES:

- While we encourage large groups outside in our Village, they cannot set-up staging or risers. There is **no power outlet** in the area designated for performances. So performers may bring their own wireless sound system – keeping in mind the volume cannot be so loud as to distract from the holiday environment or disturb surrounding tenants. We also have a wireless sound system that can be rented for a fee.
- No more than 20 performers at one time. (Includes musicians)
- Microphones or sound boards must be approved by management.
- No amplification. The only exception will be dance groups that have pre-recorded music.

Performances are scheduled from 1-8pm weekdays; 10am-7pm Saturdays; and 11am-6pm Sundays. Up to one hour may be reserved for each group's program.

If your group would like to perform, please complete and return the form below 7 days prior to your requested date. Performances are scheduled on a first come, first serve basis. A confirmation letter will be emailed to you when completed. For the safety and convenience of shoppers as well as performers, all participants will be asked to adhere to the attached guidelines.

Our customers enjoy and appreciate the variety of entertainment presented each year. We hope you will join us in this holiday tradition!

GUIDELINES FOR OUTDOOR PERFORMANCES

- ___ Please check with mall management on size approval of group performances.
- ___ Amplification must be approved by mall management.
- ___ Microphones or sound boards must be approved by mall management and need to be wireless.
- ___ Performances are required to have a “holiday” theme.
- ___ Upon arrival at the center, please check in with Security/ Guest Services located in Center Court.
- ___ All performances have been scheduled in the Village. Please arrange your group in close formation and position any equipment in a manner that preserves the natural flow of traffic and will not obstruct retailer storefronts.
- ___ *No solicitation of funds or donations is allowed.*
- ___ No distribution of business cards or flyers is allowed without prior approval by the Management office.
- ___ Any and all signage must be approved through the Management Office prior to the performance.
- ___ In order to maintain an appropriate retail environment you may be asked to adjust the volume of your performance. Please cooperate fully with any Management or Security personnel in this matter.
- ___ Due to space restrictions and liability, no personal belongings, equipment, etc. can be stored in the Management Office or other secured location.
- ___ Vehicles may unload equipment in designated loading zones only, but may not remain parked there longer than ten minutes.
- ___ No helium balloons or decorations of any kind are allowed.
